

## SPECIFIC RULES FOR MARY J Song of the Day

In addition to the General Rules posted on the website for Station, which is owned and operated by the Company, the following Specific Rules apply to this Promotion. Please consult those General Rules in addition to these Specific Rules. All capitalized terms not defined in these Specific Rules will have the meanings established in the General Rules. In the event there is a discrepancy or inconsistency between those General Rules and these Specific Rules, these Specific Rules shall control. The General Rules and these Specific Rules shall be collectively referred to as the "Official Rules".

### PROMOTION DESCRIPTION:

- Station: WMMJ-FM which is owned and operated by Urban One, Inc. d/b/a Radio One Washington, DC
- Promotion: MARY J SONG OF THE DAY
- Promotion Period: The Promotion will begin on Monday, July 6, 2026, and will end on Friday, July 24, 2026, exclusive of weekends.
- Entry Information: Participants may only enter this Promotion by calling the station as promoted on air as described below.
- Entry Method: During the Promotion Period, eligible Participants are encouraged to listen to the Station's weekday broadcasts between the hours of 10:00 AM and 3:00 PM to listen for the Mary J. Blige Song of the Day (each, a "Cue"). The 10<sup>th</sup> caller at 202-432-1023 after the Cue will become a "Qualifying Winner". Each Qualifying Winner will be awarded a qualifying prize (each a "Qualifying Prize") to be chosen at the Station's sole discretion and will be entered for a chance to win the Grand Prize. See below for further details.
- Number of Entries: Participants may call in in response to a Cue as many times as they would like to become a Qualifying Winner (as defined above). Participants may only become a Qualifying Winner **once** during the Promotion Period and are thereafter prohibited from attempting to make any further entries.
- Number of Qualifying Winners: There will be one (1) Qualifying Winners for each weekday of the Promotion Period for a total of fifteen (15) Qualifying Winners.
- Qualifying Prizes: Each Qualifying Winner will be awarded an undisclosed Qualifying Prize with an Approximate Retail Value of up to Three Hundred Dollars (\$300). Each Qualifying Winner will be awarded a different Prize that will be selected at the Station's sole discretion and disclosed after the Qualifying Winner is confirmed. See "Additional Prize Terms & Conditions" below for further details.
- Grand Prize Winner Selection: One (1) Grand Prize Winner will be selected by random drawing from among all Qualifying Winners at approximately 2:00 PM EST on Friday, July 24, 2026.

Grand Prize: The Grand Prize Winner will be awarded one (1) Prize package, which has an approximate total retail value (“ARV”) of Two Thousand Eight Hundred Forty-Two Dollars (\$2,842) and shall entitle the Winner and one (1) guest (the “Guest”), who must be at least twenty-one (21) years of age or older as of the commencement of the Promotion Period, to the following prize elements:

- One (1) pair of tickets, valued at Six Hundred Ninety-Eight Dollars (ARV \$698), to the Mary J. Blige Las Vegas Residency Tour (the “Event”), which shall be held at Dolby Live at Park MGM on Friday, August 28, 2026 (ARV \$698);
- One (1) pair of round-trip airline tickets for the Winner and the Guest from Baltimore/Washington International Airport (the “Departure Airport”) to Harry Reid International Airport (the “Arrival Airport”), valued at approximately One Thousand Six Hundred Seventy Dollars (ARV of \$1,670); and
- One (1) 2-night hotel for two (2) stay at the Las Vegas Park MGM (the “Hotel”), valued at approximately Four Hundred and Seventy-Four Dollars, (ARV \$474).

#### **ADDITIONAL PRIZE TERMS & CONDITIONS:**

For the purposes of the General Rules, the terms “Qualifying Winner” and “Grand Prize Winner” shall be referred to as “Winner” and the terms “Qualifying Prize” and “Grand Prize” shall be referred to as the “Prize.”

Participants must be 21 years of age or older to enter, and any Guest of a Grand Prize Winner must be 21 years of age or older to redeem any elements of the Grand Prize.

A Participant may choose to decline the Qualifying Prize that is offered and in such case will be permitted to make additional call-ins to attempt to win a different Qualifying Prize. A Participant who declines a Qualifying Prize is not guaranteed to become a Qualifying Winner again, and unless they become a Qualifying Winner again (and accept the Qualifying Prize), they will not be eligible to be chosen as the Grand Prize Winner.

The Station is in no way responsible for shipping errors including but not limited to: lost or stolen items (including items delivered to an incorrect address), delays in the projected shipping time, and damaged or incorrect items.
